Exhibitor releases and holds harmless the facility that is being used, sponsors, owners, managers, merchants, association, agents, servants, volunteers, employees and board members of Historic Mansfield Performance Park from all responsibility, personal liability, loss or damage, theft, loss of life, personal injury and / or damage to property that may arise or occur to exhibitor, his employees, agents, servants, associates, goods, property or the public and from any conditions whatsoever that may arise while the premises are in use, during festival hours or when closed after festival hours. We reserve the right to remove exhibitor and exhibits if agreements or rules are not complied with and whose conduct is not acceptable. Misrepresentation on the part of the exhibitor in any form will result in cancellation of space and total loss of fee. Entry constitutes an agreement that exhibitor and his representatives take no legal action against any of the above.

Rules and Regulations 2022 Mansfield Freedom Fest

Festival Hours: Sunday, Sept. 11, 2022, 4:00pm to 9:00pm

1. Vendor shall tend to booth and keep it open during the festival hours stated above.
2. Booth shall be set up and ready for business by 4:00pm on Sunday, September 11, 2022. Setup begins at 1:30pm.
3. Vendor shall remove everything from festival site by 11pm on Sunday, Sept. 11. No take down of booth or activity before 8:30 pm on Sunday, September 11, 2022.
4. **Festival will provide ONLY a 10'x10' area. Vendor will provide everything needed to set up booth and conduct business, including 10'x10' tent, tools, labor, tables, chairs, lights, extension cords, etc.**
5. Activity, display, tent poles or anchors shall stay within the 10'x10' space unless approved in advance by Historic Mansfield Performance Park.
6. Space assignment shall be at the sole discretion of Historic Mansfield Performance Park.
7. Space will be assigned on a first **paid**, first assigned basis. No space will be assigned until full payment is received.
8. No sharing of booth by multiple persons or groups allowed unless approved in advance by Freedom Fest Administration.
9. No vehicle shall be allowed except during loading and unloading. Vehicles in violation will be towed at owner's expense.
10. No food or beverage shall be sold by Vendor.
11. No RV parking shall be allowed.
12. Vendor is responsible for performing thorough background checks for any worker, agent or representative at Vendor's booth. Workers under the age of 14 must be supervised by a responsible adult.
13. Festival is an outdoor event held regardless of weather conditions. Vendor should plan accordingly.
14. Vendor shall be responsible for collecting and distributing any applicable state/local tax.
15. Vendor shall be responsible for the clean up of trash from and around their booth.
16. Vendor shall retain liability and assumes all risk of loss and/or damages on site or in connection with transportation, theft, display, storage of craft or activity at the festival.
17. Historic Mansfield Performance Park reserves the right to decline an application if they deem the product not suitable for the festival or if there are numerous applications previously approved to provide similar items or services. Historic Mansfield Performance Park is not responsible for duplication of items or services among Vendors.
18. Historic Mansfield Performance Park does not guarantee in any way the success of a Vendor.
19. Historic Mansfield Performance Park shall have full power to interpret or amend these Rules and Regulations without further notice.
20. **Historic Mansfield Performance Park decision must be accepted as final in any dispute between the Vendor and Historic Mansfield Performance Park.** Historic Mansfield Performance Park has the right to stop or remove from the festival a Vendor who violates these rules and regulations, does not abide by Historic Mansfield Performance Park decision, or dresses or performs any act which, in the sole opinion of Historic Mansfield Performance Park is objectionable or detracts from the festival.
21. Once application has been approved, no refunds will be given under any circumstances.
22. In case of rain, Historic Mansfield Performance Park will make every reasonable effort to proceed with the event. Historic Mansfield Performance Park reserves the right to cancel the event at its sole discretion due to severe weather, act of God or other circumstances beyond the control of Historic Mansfield Performance Park and **a reasonable effort will be made to reschedule the event to a future date.**
23. Violation of these Rules and Regulations will result in forfeiture of space without refund and prohibit Vendor from participating in future festivals.

Agreement of Liability Waiver

I, THE UNDERSIGNED, HAVE READ AND AGREE TO COMPLY WITH THE ABOVE RULES AND REGULATIONS; I UNDERSTAND THAT AGREEMENTS OR PROMISES MADE VERBALLY AND NOT SPECIFICALLY STATED AND CONFIRMED IN WRITING AS PART OF THIS DOCUMENT SHALL NOT BE BINDING; I HEREBY INDEMNIFY, RELEASE, WAIVE, DISCHARGE, COVENANT NOT TO SUE AND AGREE TO HOLD HARMLESS FOR ANY AND ALL PURPOSES HISTORIC MANSFIELD PERFORMANCE PARK, ITS OFFICERS, AGENTS, SUCCESSORS, ASSIGNS, SPONSORS AND VOLUNTEERS (COLLECTIVELY "Historic Mansfield Performance Park") FROM ANY AND ALL LIABILITIES, CLAIMS, DEMANDS, PERSONAL INJURY INCLUDING DEATH, OR PROPERTY DAMAGE THAT MAY BE SUSTAINED BY ME AND ANY OF MY EMPLOYEES, VOLUNTEERS, AGENTS OR CONTRACTORS WHILE PARTICIPATING IN THE MANSFIELD FREEDOM FEST 2022, INCLUDING INJURIES AND DAMAGES SUSTAINED AS A RESULT OF THE NEGLIGENCE OF HISTORIC MANSFIELD PERFORMANCE PARK AND/OR FREEDOM FEST ADMINISTRATION.
